**REVIEW AGENDA/ADDITIONS** – Ms. Stephan asked that we add a review of how the year went and of the deliberative.

**BUDGET RECOMMENDATION:**

Ms. Gannon explained that this meeting was called in response to an email from Ms. Coppola indicating that legal counsel had advised her that if the school board and budget committee wanted to change their vote on recommending the budget since a new amount was approved at the deliberative, they would need to hold an official meeting to do so in time for publishing the annual report and ballot. The budget amount was amended to \$34,117,000 and approved by district voters at the February 3 deliberative session.

The numerical vote for and against recommending the amended budget amount will appear on the official ballot.

The Committee reviewed the minutes and made several amendments. **VOTE to accept:** 5-0 Unanimous

**NEW BUSINESS**

Members made various comments reviewing the deliberative and the budget season. Several commented that they felt that the community had become divided in a way that created an “us against them” atmosphere. Ms. Stephan was contemplating some new ideas for next year should she be re-elected. Ms. Gannon was discouraged that after all the committee’s work and deliberation on trying to come up with a justifiable budget that had minimal impact on the students, a number with no justification was proposed and accepted. But she acknowledged that is the system.

**PUBLIC COMMENT** – No public comment

**COMMITTEE COMMENT** – Ms. Faria read a statement in which she related an experience where she felt intimidated when approached by a member of the Newton Kingston Taxpayers Association after the deliberative session.

**MOTION** to adjourn Mr. Gluck; **Seconded** by Ms. Ross.

**VOTE:** Unanimous.
